

Waiver For Participation In Embrace Our Green Space Race March 26, 2011

By indicating your acceptance, you understand, agree, warrant and covenant as follows: PARTICIPANT REGISTRATION AGREEMENT AND LIABILITY WAIVER (the "Agreement and Waiver") Authority to Register and/or to Act as Agent. You represent and warrant to organizers and sponsors of this event that you have full legal authority to complete this event registration on behalf of yourself and/or any party you are registering (the "Registered Parties"). If you are registering a child under the age of 18 or an incapacitated adult you represent and warrant that you are the parent or legal guardian of that party and have the legal authority to enter into this agreement on their behalf and by proceeding with this event registration, you agree that the terms of this Agreement and Waiver shall apply equally to all Registered Parties. By registering a child under 13, you agree and consent to the collection of that child's information which you provide for the purposes of registration.

Waiver. YOU UNDERSTAND THAT PARTICIPATION IN THIS EVENT IS POTENTIALLY HAZARDOUS AND FULLY REALIZE THE DANGERS IN PARTICIPATING IN THIS EVENT, AND THAT A REGISTERED PARTY SHOULD NOT PARTICIPATE UNLESS THEY ARE MEDICALLY ABLE AND PROPERLY TRAINED. YOU UNDERSTAND THAT EVENTS MAY BE HELD OVER PUBLIC AND PRIVATE ROADS AND SIDEWALKS AND FACILITIES OPEN TO THE PUBLIC DURING THE EVENT AND UPON WHICH HAZARDS ARE TO BE EXPECTED. PARTICIPATION CARRIES WITH IT CERTAIN INHERENT RISKS THAT CANNOT BE ELIMINATED COMPLETELY RANGING FROM MINOR INJURIES TO CATASTROPHIC INJURIES INCLUDING DEATH. YOU FULLY ASSUME THE RISKS ASSOCIATED WITH SUCH PARTICIPATION, INCLUDING, by way of example but not limitation: dangers associated with collisions with pedestrians and spectators, other participants, vehicles and other riders, and fixed and moving objects; the dangers arising from surface hazards, including pot holes and oil slicks, equipment failure, inadequate safety equipment, the negligence of others and weather conditions, etc. YOU UNDERSTAND AND AGREE THAT IN CONSIDERATION OF BEING PERMITTED TO PARTICIPATE IN THE EVENT, YOU AND ANY REGISTERED PARTY, THE HEIRS, PERSONAL REPRESENTATIVES OR ASSIGNS OF YOU OR THE REGISTERED PARTY DO HEREBY RELEASE, WAIVE, DISCHARGE, HOLD HARMLESS, AND CONVEYANT NOT TO SUE ALL SPONSORS, ORGANIZERS, VOLUNTEERS, PROPERTY OWNERS, ENFORCEMENT AGENCIES, PUBLIC ENTITIES AND THOSE IN ANY MANNER CONNECTED TO THIS EVENT and their respective agents, officials, and employees through or by which this event is held, FOR ANY AND ALL LIABILITY FROM ANY AND ALL CLAIMS ARISING FROM PARTICIPATION IN THE EVENT BY YOU OR ANY REGISTERED PARTY.

As a participant you recognize that this event will take place on public and private roads and sidewalks, and agree to abide by all traffic signs, lights, use crosswalks where marked at intersections, and obey all other official traffic control signage and directions. Participants also agree to follow the marked routes and obey any instructions from on-course event volunteers. All cyclists and skaters shall also wear helmets and all appropriate protective gear for traveling on a fast course with long downhill steep slopes and rough surfaces.

Indemnification. You agree to indemnify and hold the sponsors and organizers harmless from and against any and all damages, costs, claims or demands, including reasonable attorneys' fees, made by you or any third party due to or arising from or relating to your participation in this event.

Applicable Law; Consent to Jurisdiction. The laws and jurisdiction of the State of Georgia shall apply. **Severability.** You further expressly agree that this Agreement and Waiver is intended to be as broad and inclusive as is permitted by the law of the State of Georgia and that if any provision of this Agreement and Waiver shall be found to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and Waiver and shall not affect the validity and enforceability of any remaining provisions.

BY INDICATING YOUR ACCEPTANCE OF THIS AGREEMENT AND WAIVER, YOU ARE AFFIRMING THAT YOU HAVE READ AND UNDERSTAND THIS AGREEMENT AND WAIVER AND FULLY UNDERSTAND ITS TERMS. YOU UNDERSTAND THAT YOU ARE GIVING UP SUBSTANTIAL RIGHTS, INCLUDING THE RIGHT TO SUE. YOU ACKNOWLEDGE THAT YOU ARE SIGNING THE AGREEMENT AND WAIVER FREELY AND VOLUNTARILY, AND INTEND BY YOUR ACCEPTANCE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.

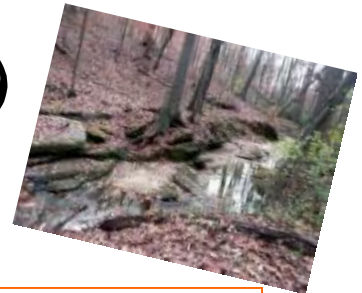

Carey Hansard Park- 2+ acre passive greenspace on the corner of LaVista and Clairmont Roads that was purchased with funds collected from area residents.

Mary Scott Nature Park- 10.6-acre woodland located at 4150 Briarcliff Road, just behind Shallowford Road churches. Woodland paths, a small parking lot, a children's play area and picnic tables were installed in 2010 .
