Explanation of Terms

Burglary -	Theft or attempted theft from residence or business
Check Location -	An officer verifies the status of a location by checking Doors and windows or patrolling in reference to possible criminal activity
Criminal Trespass -	Vandalism (i.e. mailbox bashing, lawn trenching, broken windows, etc.) with no evidence of attempted entry
Disorderly Juveniles -	A call made in reference to someone under the age of 17 possibly creating a disturbance
False Alarms -	Officer dispatched to an audible alarm. After checking the premises, there are no signs of a burglary or damage
Misc. Service Request -	An officer was requested to a location for other reasons outside of criminal activity or writing a report (i.e. to answer a question, advise on a situation, etc.)
Narcotics Violation -	Subjects reported to be engaged in some type of activity Involving illegal narcotics (selling, using, distributing)
Patrol Request -	Resident in the community requested additional officer patrols in the area. Officer initiates during his work shift
Property Damage -	When damage exceeds \$500
Robbery -	
Armed-	Theft from a person using a weapon (i.e. gun, knife)
By force-	Theft from a person using physical force with no weapon
Suspicious Person/Vehicle -	A person seen in the area who appears out of place or having no business in the area
Theft by Taking -	Theft from outside the home (from yard, porch, auto, carport, etc.)
Theft from a Vehicle	Theft from a locked or unlocked vehicle
